



Terms & Conditions

Registration

- All parents / carers must complete our Registration Form before a child can be accepted at a **Seaside Wrap Around Care**.
- A collection password must be assigned to each child for pick-ups when registering.
- **Seaside Wrap Around Care** must be notified of any changes in registration details, as soon as possible, in writing by the parent / carer.

Booking Sessions

- All sessions requested by parents / carers are subject to availability.
- All sessions booked must be paid for **in advance**.
- No parent / carer should consider a booking as being accepted until payment has been received by the Club.
- Bookings may be made up to 24 hours before the start of any session. Children will not be able to be booked in after that time.
- Bookings may be cancelled or changed up to **7 days before the start of the session – changes may not occur after this time.**
- Parents / carers of children not booked into the Breakfast club or After-School Club, but who subsequently attend, will incur a **£10.00 non-booking fee per child, in addition to the cost of the session.**
- *School children who remain at the school uncollected after **3.10pm** will be admitted into the After-School Club, whilst their parents are contacted to collect them. **The parent / carer will incur a £10.00 non-booking fee per child in addition to the session charge.**
- A full session is still chargeable even if a child attends an after-school activity club.
- **Seaside Wrap Around Care** will credit all fees charged, if the club is forced to close due to unforeseen circumstances.

Responsibility for Attendance

- It is the parent / carer's responsibility to ensure that their child / children arrive, on time, to any part of the **Seaside Wrap Around Care**, and are signed in accordingly.
- It is the parent / carer's responsibility to ensure that their child / children are aware that they will be attending any part of the **Seaside Wrap Around Care**.

- It is the parent / carer's responsibility to notify the school if there are late changes made to their child / children's club attendance on that day.

Collection and Penalties for Late Collection

- *For After-School Club, parents need to call the After-School Club mobile and they **MUST collect their children from the door to be signed out**. This is part of the safeguarding arrangements for drop offs and pick ups.
- Parents/carers must ensure that any person who may collect their child is aware of the **password** for collection and club staff have previously been made aware of a different adult collecting.
- Parents/carers must ensure must advise the office if a child has been booked into the club and is **NOT** attending, for any reason, for example they have a playdate, this must be communicated as part of safeguarding the child.
- It is the responsibility of all parents / carers collecting children to do so **promptly at the end of the session (within 5 minutes of the next session)**. Failure to do so will expose the parent / carer to the payment of a financial penalty and will constitute a breach of the terms and conditions, entitling part of the **Seaside Wrap Around Care** to exclude the child from subsequent sessions.
- There is a penalty charge of **£5.00 for every five minutes** (or part thereof) for each child collected after the **official closing time of the club**.
- Any penalties must be paid before any future bookings are made with **Seaside Wrap Around Care**.
- Where the penalty is outstanding and further sessions have been pre-booked and paid for by the parent / carer, **Seaside Wrap Around Care** reserves the right to exclude the child from the club, until the penalty is paid, without issuing a refund for sessions unattended.

Responsibility for Payment

- The responsibility for payment of all fees, charges and penalties lies at all times with the person who has made the booking.
- Failure by **Seaside Wrap Around Care** to make a written or verbal request for payment of fees does not constitute an excuse or reason for late, or non-payment under any circumstances.
- Failure to settle all fees and/or penalties when due may result in **Seaside Wrap Around Care** taking action (including legal action) to recover any outstanding sums.

Childcare Vouchers

- Childcare Vouchers will be credited to individual accounts only when the funds have been received by the school. Please note that many Childcare Voucher Providers take up to 7 days to allocate these funds to the school, therefore you must allow 14 Days for this credit to be transferred across to your account.
- The school is registered with a number of Childcare Voucher Providers
- If you intend to use a Childcare Voucher Provider, which is not currently registered with the school, please email **our office** with the Provider's information in order for the school to register. Bookings will need to be paid for by card until this registration process is complete.

Grounds for Exclusion

- Any child who has suffered from diarrhoea, sickness, high temperature/fever, conjunctivitis or any contagious disease must be kept away from **Seaside Wrap Around Care** for a period of 48 hours after such condition has ceased.
- Should any child suffer from any of the above whilst at **Seaside Wrap Around Care**, the staff will contact the parent / carer and ask them to collect the child as soon as possible.
- Other grounds for exclusion are **persistent poor behaviour** on the part of the child or the parent / carer, (which includes, but is not limited to, bullying, verbal abuse, physical violence, fighting, racial incidents, defiance, rudeness to others, dishonesty, disobedience and deliberate damage to property), or non-persistent incidents of particularly serious behaviour (for example those which endanger children or staff) or where a parent / carer is in breach of any of our terms and conditions.
- Refunds will not be made if children are excluded on the grounds set out above.

Reservation of Rights

- **Seaside Wrap Around Care** reserves the right to exclude a child or family from attending the Club or to refuse to accept a registration at its sole discretion.
- **Seaside Wrap Around Care** reserves the right to close the club on the grounds of staff shortage, unavailability of facilities, or for any other reason, which in its reasonable opinion necessitates closure. Reasonable notice will be given where possible.
- **Seaside Wrap Around Care** reserves the right to change these terms and conditions at any time.

Legal: Waivers, Exclusions and Jurisdiction

- No failure or delay by **Seaside Wrap Around Care** in exercising any of its rights or remedies shall prejudice or affect its ability to do so unless it has provided a specific waiver or release in writing.
- These terms and conditions are governed by English law and subject to the jurisdiction of the courts of England and Wales.
- **Seaside Wrap Around Care** shall not be liable for any direct or indirect loss suffered by parents / carers as a result of club closures under the terms of the agreement, including but not limited to loss of profits, increased costs or expenses or wasted expenditure.
- **Seaside Wrap Around Care** accepts no liability for the administration of medicine in accordance with parents / carers written instructions. Medicines will not be administered in the absence of written instructions.
- In accordance with **Seaside Wrap Around Care** - Health Policy, **Seaside Wrap Around Care** accepts only medication which is prescribed, in original packaging including the pharmacy label which indicates the child's name.
- **Seaside Wrap Around Care** accepts no liability for loss or damage (including consequential loss) to property brought to club premises caused by the actions of children or third parties or for accidental damage caused by club staff.
- **Seaside Wrap Around Care** accepts no responsibility for injury caused from pre-existing medical conditions which are not notified to the club.
